Terms of Agreement

Minnesota Street Market will:

- Provide reasonable and safe (from breakage and theft) display space for each consignee based on size of goods/art.
- Approve Consignee display and fixtures.
- Feature Consignee bio/story in at least one FB post and one Newsflash article.
- Feature Consignee in St. Joseph Shop Small Crawl promotion (social media).
- Retain 25% of retail sales from artists who are MN Street Market members.
- Retain 30% of retail sales from artists who are *not* MN Street Market members.
- Pay Consignee 15 days after the close of each month of business.
- Review Consignee performance quarterly – making suggestions to improve sales and presentation if needed.
- Review Consignee Application and Agreement annually to determine renewal.
- Notify Consignee if art/product needs to be temporarily moved to make room for events, meetings or repairs.

Consignee will:

- Sell only original art/goods, unless approved otherwise.
- Label each item for sale clearly with price **and** Consignee's initials.
- Provide a completed application with photos of items for sale as well as photo(s) of how the item will be displayed.
- Replenish inventory and clean display area monthly. This action is monitored by a Consignee Check Sheet posted in Minnesota Street Market.
- Promote the availability of their goods at the MN Market via social media at least four times per year.
- Be liable for loss or damage goods.
- Be liable for any problems/injuries/damage experienced by consumers from their goods, both while displayed and after purchase.
- Remove all unsold goods within seven days of the end of Agreement.

General agreement information:

- Minnesota Street Market or the Consignee may terminate the Agreement at any time with a 30 day notice.
- Minnesota Street Market will review the terms of this Agreement/Application annually (typically January) and may make changes. If changes are made, the Consignee will be notified.
